

HOW TO FLY MASK-FREE

(Hint: you probably can't)

My story:

In July of 2020, during a relative “summer lull” in the covid chaos, I was invited to speak as a featured guest at a rally in Sacramento, on the steps of the Capitol building.

This was a rally to protest masks and other unlawful restrictions imposed by the tyrants and evil-doers masquerading as public servants.

Back in July, before the airlines went overboard in violating everyone’s rights, I called Southwest to see what their mask policy was. (Remember, a “policy” is not a law. And business “policies” cannot be implemented when they violate laws or rights. No business could require you to snort a line of cocaine as a condition of being served, so how can they require you to self-suffocate?)

Southwest told me on three occasions that masks were requested, but not required. And that exemptions were honored.

I spoke with three different agents, and recorded one of the conversations, where we even had a few chuckles over the fact that it was a “good thing” that I was flying on Saturday, because the following Monday was when the mask requirement would go into effect. I said, “wow, I’m just getting in under the wire,” and the booking agent agreed with me.

After I booked my flight from Orange County to Sacramento I printed out Southwest’s non-discrimination policy which assured

SUGGESTED ACTIONS:

1. Call the airlines and get everything in writing if they allow for exemptions
2. Delay the trip
3. Drive
4. Fly private
5. Have the other party visit you

I hope these options will help you!

Even though I confirmed at booking that I would be able to fly without a mask because the mandate was not until Monday, and even though I had it in writing and printed it out, □I was denied boarding and was discriminated against, and I was unable to attend a rally at which I was going to be a featured speaker. I guess wearing a magic mask makes people magically "healthy" -- no need to take care of your health, just "wear the dang mask!!" LOL

On my way or at least attempted to go to Sacramento to speak at a freedom rally. Despite being told the masks were not mandatory until Monday, despite my printing out their non-discrimination

policy, despite my having exemptions, I was still denied the right to board. This is violation of civil rights on so many levels. More troubling to me than this airport personnel were the so-called patriots that were traveling as well yet complied with the masks even though they say they are fighting against them. There's talk and then there's action.□
